Dear Ms. Shofner:

This officer shall be President of the Executive Council Members. This officer shall execute any duties assigned to him or her by Bylaws or Executive Council. This officer shall appoint committee members and designate the chairperson of each committee.

For more than 15 years Dr. Haun edited the TSCA Journal and was supported by the Valenti School during those years. She has always multi-tasked well and should be able to manage these extra responsibilities. She is likely to have a two or three course teaching load each semester and all of her classes have a strong on-line component which permits schedule flexibility.

The Valenti School is appreciate of the role of TSCA and is pleased to have this opportunity to offer support.
