

#### **RudeBusters!**

( Sang to the tune of Ghostbusters)

There's something MEAN, in the neighborhood, who ya gonna call "RUDEBUSTERS"!!!

Bad manners here, incivility there! Who ya gonna call

"RUDEBUSTERS"!!! Yaaaaaaaaaa.......

Let's face it; the Golden Rule as we knew it, is tarnished. Common Courtesy doesn't exist anymore. Civility, manners, and politeness are nostalgic "memories". WE are more mean spirited today than ever. Whether at school, work, concerts, in supermarkets, at sporting events, at TSCA or TFA, you name it, it's everywhere. People are selfish, angry, rude and crude. America seems to be sliding down a slippery slope toward a cesspool of misbehavior. YUCK! The Arizona Daily Star's headline of March 19, 2001, addresses the problem: "Stressed out American Society Gives Birth to Rage of All Kinds". AND it is not just in the United States. In the October 7, 2005 edition of USA Today a headline read, "Government wants Britons to Mind their Manners" and a day of courtesy was declared in response to rampant rudeness. It's pretty sad when a special day has to be set to be nice. The world has become, I guess you could say, etiquette challenged! Incivility is a growing problem, and WE can be part of the solution as advocates for respectful communication!

But before we attempt to solve this wicked little problem, we better know its parameters! What is incivility? Metawikimedia.org, September 2006 defines incivility as behavior that creates an atmosphere of animosity and disrespect being a source of conflict and WIKISTRESS! Examples of incivility in the classroom might include grandstanding, excessive lateness, text messaging, verbal or physical attacks to students and teachers, or disputing authority. From teachers – criticizing your students or coworkers in public, using foul language, being late to class all the time, being unprepared for class. At TSCA, piling up the food on not one, but two plates at the feed trough, and (cell phone rings – thank you Glynis for your impeccable timing -Natalie answers the phone and carries on a conversation with Glynis for about 30 seconds.) AND my biggest pet peeve, ringing cell phones during meetings! In corporate America such examples as embezzling, lying, cheating, or spouting out racial, ethnic or religious slurs, sexist jokes, and the list goes on.

According to Civility Associates at civility associates.com, May 2005, a recent United States Department of Justice study concluded that the most dangerous place to be in the United States today is the workplace. When there is aggressive and disrespectful behavior in our workplaces, its effects have a negative impact on productivity, morale, retention, profits and wellness both of the company and individual employees. Here are just a few studies! OfficePro magazine, June/July issue 2003 cites a study by the University of Michigan researcher Lilia Cortina that found 71 percent of 1,100 workers surveyed had experienced workplace incivility in the previous five years. Such behavior wasn't from customers necessarily, but from coworkers and superiors. On the Work Doctor Website at workdoctor.com, September 2006, Christine Pearson, a management professor at the business school of the University of North Carolina sent out 4,000 questionnaires nationwide. The respondents were asked to describe an unpleasant interaction in which they were the target of rudeness and disrespect, then asked how they responded. 12% said they intentionally decreased the quality of work; 22% decreased their work effort; 28% lost work time trying to avoid the person; 52% lost time worrying about the person and the interaction; 46% contemplated changing jobs, and 12% actually changed jobs to escape the bully. Furthermore, in a survey of 1300 business professionals across the United States, 58 percent of the respondents take their business elsewhere when they encounter rudeness as cited in eticon.com, September 2006.

So who is doing the dirty deeds? Well, according to the Ivey Business Journal Nov/Dec 2003 issue, men and women alike are bullies. So pat yourself on the back folks, you too are a bully! Women comprise 58% of the perpetrator pool, while men represent 42%. Once again, women move to the forefront, but this time its nothing to brag about. From whence do these men and women come? They were our students just a few years ago that were raised by apathetic parents! They were the ones with the "You owe me" – "It's all about ME" mentality. Incivility begins in the home, continues in our classrooms, and explodes in the workplace.

This brings us to the solution. How do we as communication professionals help clamp down on incivility? The first step in bringing back civility is as Michael Jackson claimed in his 1987 release of "Man in the Mirror." "If you want to make the world a better place, take a look at yourself and make a change." Too bad he didn't practice what he preached! Civility is a code of behavior acquired by learning from others and by constant practicing. We weren't born civil; we weren't born rude! We've learned it! Life is a relational experience. George Washington's first rule of Civility was, "Every action done in company ought to be with some sign of respect to those that are present." Do you remember the "Random Acts of Kindness" movement? Doing good deeds because you wanted to and had the ability to, not because you had to! An ABC News poll in May 1999 confirmed that 85% of Americans feel that a simple "thank you" or "please" would make the world a better place.

Along that same line of thinking, we each can make the world a better place by teaching our children and students that character does count. In the previously cited ABC news report, more than 8 out of 10 Americans say the failure of parents to instruct their children in good behavior is a major cause of bad manners. However, let's be real! Who is around these students just as much, if not more, than parents? We are! "Children learn as much from observing adults and then imitating and modeling their behavior, as they do from actual instruction," according to Dr. Michael Lewis, University Distinguished Professor at the Robert Wood Johnson Medical School in New Jer-

sey. Public schools all across the nation have adopted the Character Counts program started by the Josephson Institute of Ethics in 1987 and it seems to be working! This program encourages teaching, modeling, learning and practicing daily within all lesson plans the six pillars of character – trustworthiness, respect, responsibility, fairness, caring and citizenship. Why does this have to stop in the public schools? Why can't we make a conscious effort to reinforce good character in higher education, administration, TSCA, TFA, and the business world? We can and we certainly are all trained in effective problem solving and conflict management. These pillars of character need to be in the classrooms, boardrooms, and offices all across the world. As educators, we can make a HUGE difference in the future of our world if we will just train our students to be civil. If we let our children and students get by with uncivil behavior it will rub off on everyone with which they are associated! My mother and father always told me as I was growing up, "If you hang out with the skunks long enough, you'll start smelling like them too! You should instead soar with the eagles." We need to rise up and demand respectful communication. As Nike's slogan professes, "Just do it?" As Larry the Cable Guy says, "Git 'er done!"

Finally, how do we solve incivility in TSCA. We too need to practice good character for the sake of our association as well as our discipline. Out of the six pillars, through observation over the last three years as an officer, the one that stands out as an area we ALL need to improve upon is "responsibility". In fact, when an individual is responsible and accountable to them self and others, all the other pillars are met as well through the process. I consider responsibility the foundation and the other five character traits the pillars. Cynthia Hobbs, a second grade teacher at Smyer Elementary School in a personal interview on September 23, 2006, stated that through Character Counts she has implemented a quick "respect authority and do as you were told step" that has been the root of success in her classroom. The steps are: do what you were asked to do the first time, quickly, quietly, completely, and cheerfully.

TSCA could benefit from that little elementary rule. Many of you are in leadership positions on the Executive Council and even if you aren't in one of these positions, everyone has an obligation to the Association to "Ask not what TSCA can do for you, but what you can do for TSCA! When asked to help out on a project whether you are an officer or a member of a committee, district, or interest group – do it as soon as possible, without drama, carry it through to the end even if you don't like it! I have always heard that about 10% of an organization does all the work every time. Let's not let that to be true of TSCA. Since we learn by example, let me share with you how the "character" of some of our members has shone over the past year.

- April Caldwell frequently sent me emails over my past three years asking, "What can I do
  to help!" Just in the last month April was repositioned as the chair of an important standing committee due to the resignation of the previously appointed chair. She accepted graciously and went to work on the committees charge involving all committee members.
- This summer we desperately needed strong representation at the SBOE meeting to testify in support of speech remaining a requirement for graduation. When asked to testify, Richard Cheatham, Russell Kirkscey, and Janice Caldwell stepped up to bat and made a positive impact on the SBOE in the name of TSCA.

- When I was anxious about the letter I would be sending to the SBOE as the president of this great organization before the July meeting, I emailed my letter to Virginia Myers and asked for her opinion and expertise to make sure I had historically represented our stance. She went above and beyond the call of duty in sending me recommendations.
- Bill Schuetz is an incredible gentleman who is quick to help anyone
  with anything. He is truly one of the most honest, trustworthy people I know.
- Trudy Hanson after all her hard work on the Texas Speech Communication Journal was told...."We don't have the money to publish and mail this second journal." Trudy didn't complain. Instead, she found a way to make it happen.
- Patty Brant, Richard Kincaid, Krin Perry, and Debbi Hatton have been working on some great projects to assess the effectiveness and problems of our high school speech programs across the state of Texas. They took the initiative on these projects and are getting results we desperately need.
- And I don't even know where to begin on the list of Good Deeds done by the three musketeers - Ann Shofner, Lou Ann Seabourn, and Connie Mckee.

What do these and others of our membership have in common. They are doers! When you ask them to jump, they say "How high?" HUA! Heard, Understood, Acknowledged! That's what I'm talking about! Members being responsible the first time, quickly, quietly, completely, and cheerfully. This will enable TSCA to make a huge impact on society civilly. But it will take the entire membership to make civility a reality at home, at work, and at play!

Well, I think I've been on my "incivility" soapbox long enough. Incivility is a growing problem in our families, schools and businesses, but we all can make a difference by emphasizing respectful communication. We must not only talk the talk, but walk the walk daily! The future of civility in America need not be dismal. Good guys and gals don't have to always lose. Parents, teachers and organizations that look at others with inherent value will succeed. (sing) So when there's something mean in today's classroom, bad manners here, incivility there, who ya gonna call? It's simple! Call the RUDEBUSTER in the mirror and make the change.

THEREFORE BE IT RESOLVED, that the members here assembled give a resounding YEE HAW to the 2006 Local Arrangements Committee.


WHEREAS, News Anchor Andy Justice, welcomed us to Amarillo as one who truly knows us; and

THEREFORE BE IT RESOLVED that Jana Riggins can rest assured that THIS report is neatly typed, collated, and ready for the archives.



#### **Call for Manuscripts**

Texas Speech Communication Journal Volume 32

The *Texas Speech Communication Journal* issues a call for papers that focus on human communication and the Internet. Papers can examine topics such as On-line Relationships, Virtual Communities, The Virtual Citizen, Private/Public/Digital Space, Electronic Surveillance, Power and Cyberspace, The Virtual Individual, The Virtual/Real/World Divide, Rhetorical Performance, Identity Play, etc. Papers may also address human communication and the Internet related to distance education and on-line course development.

Contributors may approach the topic from a variety of perspectives: critical/rhetorical, qualitative, and quantitative. Teaching Tips submitted for Volume 32 should reflect best practices in teaching human communication and the Internet. Manuscripts should be received no later than **February 10**, **2007**. Manuscripts not devoted to the topic of human communication and the Internet will be considered for the research section of the issue as space allows. TSCJ follows a policy of blind review so no author identification should appear in the body of the manuscript.

Manuscripts should not exceed 25 pages and be written according to the *Publication Manual of the American Psychological Association (5th edition)*. The title page should include the author's name, academic position, institutional affiliation, full mailing address, telephone number, email address, brief author bio, and a history of the manuscript (presentation at conferences). An abstract of not more than 150 words should accompany the manuscript. The author should also include keywords for the article. Email submissions are preferred for both manuscripts and teaching tips (either in WordPerfect or Word.). The format for Teaching Tips should include learning objectives, description of preparation needed for the activity, a description of the activity, instructions for debriefing and a list of resources.
